



CFIP PURPOSE

The purpose of the California Forest Improvement Program (CFIP) is to:

- encourage private and public investments in forestlands and resources within the state
- ensure adequate future high quality timber supplies, related employment and other economic benefits, and
- protect, maintain, and enhance the forest resource for the benefit of present and future generations.



CFIP Funding

- ▶ \$11 million 2022-23
- ▶ \$13 million 2023-2024



WHAT THE PROGRAM DOES?



- CFIP is a reimbursement cost-share program, not a grant program
- ► CFIP typically provides reimbursement 75% to 90% of the state cap cost of a project
- CAL FIRE has developed an advance program for up to 25% of agreement cost
- Maximum of 120 days to get reimbursed

ELIGIBLE LANDOWNERS

- ► Landowners must own at least 20 to 5,000 acres of forestland
- ► Forestland means land at least 10 percent occupied by trees of any size that are native to California



ELIGIBLE LANDOWNERS continued

- ► Eligible landowners include:
 - Private persons
 - ▶ Government agencies
 - ▶ LLCs, Trusts, Corporations
 - Non-federally owned Native American lands
- ► CFIP contracts with the <u>deeded</u> landowner.
- ► Lease holders are not eligible.



Requirement for a Forest Management Plan

- ► The enabling legislation for the California Forest Improvement Program (CFIP) requires that a Forest Management Plan be prepared and approved prior to a forest resource improvement project being started.
- An existing non-industrial timber management plan (NTMP), CFIP management plan, or NRCS management plan may be adequate.
- ▶ If a new or revised management plan is required, then the program can provide cost share funding for its completion by a private RPF.

CFIP Emergency Forest Management Plan (EFMP)

- For properties that have been substantially damaged by natural causes and are in immediate need of reforestation
- Emergency notice submitted and completed
- The Department has developed the Emergency Forest Management Plan (EFMP) to meet the intent of a management plan that will be automatically approved upon contract approval.





Minimum Acreage of Eligible Projects

- Forest improvement practices must cover at least a contiguous
 5-acre project area.
- ► There is no minimum acreage limit for land conservation or habitat improvement projects.

NO Commercial Timber Operations



Commercial timber operations require the approval of a timber harvest plan, non-industrial timber management plan, emergency notice or exemption by CAL FIRE under the Z'berg-Nejedly Forest Practice Act of 1973 (Forest Practice Act).



A CFIP application for only a Forest Management Plan may overlap commercial operations.



A proposed CFIP project with ground practices overlapping commercial operations shall not be approved until after either:

A final completion and stocking report has been approved An exemption or emergency has expired and been inspected by the FAS to verify that operations are completed.



Proposed CFIP projects adjacent to approved commercial harvesting operations shall include close coordination with the local Forest Practice Inspector and may be approved.

III. How to Get Started

- ► Step 1: Contact a FAS
- ► Step 2: RPF submits application
- ► Step 3: Field inspection
- Step 4: Final application filed and ranked
- Step 5: Application approved or denied funding

CFIP Cost Example

- ► 20-acre management plan = \$6060
- Archaeology Report = \$2028
- ► 5-acre thinning = max \$6000
- ► 5-acre slash treatment = max \$6000
- ► RPF supervision = \$1250
- > \$21338 total
- ► Landowner cost = \$2133.80
- ► Unknown additional costs, RPF prepare application = \$700-\$2500, contractor over budget.



Practice Rates

- ► Rates for each practice are published
- ► Rates are dependent on site conditions
- ► Rates can't be exceeded
- Rates are continually reviewed and updated

Wildfire Resiliency Block Grants

- ▶ Due to inadequate CAL FIRE staffing and significant funding, CAL FIRE provided block grants in 2020 and 2022
- ► Grant to counties, resource conservation districts, special districts, and 501(c)(3) non-profit organizations that have the capacity to deliver a forestry based technical and financial assistance program to non-industrial forest landowners
- ► Grants up to \$4 million
- ► Grantee provides in-house technical assistance for individual landownerships between 3 and 5000 acres.
- ▶ Undetermined whether there will be an application period in 2023
